- Striving to promote the comprehensive development and enhancement of legal science;
- Recognizing the need to train highly qualified specialists in law;
- Recognizing the importance of developing international cooperation in the academic and scientific work;
- Desiring to establish partnerships with each other,

Have agreed as follows:

I. General provisions

1. Cooperation in the field of education and science is carried out in the field of basic and applied legal disciplines (constitutional law, ICT, civil and criminal law, civil and criminal procedural law, international public and private law, etc.).
2. The Parties shall cooperate in the field of education and science on the basis of mutual respect and institutional independence principles, which shall include:
 - Exchange of experience and information;
 - Conducting and participating in conferences;
 - other joint educational and research projects.

II. Experience and information exchange

3. Exchange of experience and information presupposes that one participant in the contract may use the scientific potential of another participant within the framework of the applicable copyright laws of the State concerned.
4. The Parties shall form:
 - Conducting lectures, consultations, internships of their teachers and scientists for joint research and methodological work;
 - Realization of exchange of scientific, educational, educational and methodical literature, curricula, programs, bibliographic and reference literature;
 - conducting joint research activities on topical issues of mutual interest;
 - Making joint textbooks, study guides, monographs and scientific articles;



- Publish publications of the staff of the Parties in the university publications; encourage cooperation between departments of the department;
- exchange of students.

III. Conducting and participating in conferences

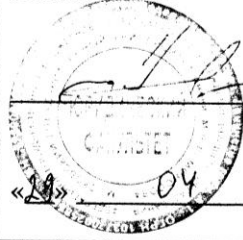
5. The Parties shall jointly hold international conferences on topical issues of legal science. Any Party may initiate the Conference. All issues related to the organization and conduct of the conference are determined by the specially established organizing committee. Organizing committee members are approved by the initiator of the conference.
6. The Parties shall be established by inviting the representatives of the faculty to participate in conferences held by one of the Parties and to exempt them from their registration

IV. Additional rules

7. The signed contract does not exclude the possibility of carrying out other cooperation arrangements, which may be agreed upon by the parties.
8. The specific cooperation arrangement and other current issues are defined in the cooperation protocols for a specific period of time. The Parties shall exchange delegations of the authorized representatives for the signing of the Protocol.

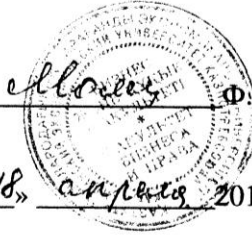
