1.3 Invitation of employees of the Department of Internal Affairs of Karaganda region for joint research and research work of the departments;

1.4 Involvement of employees of Department of Internal Affairs of Karaganda region for carrying out study classes;

1.4 To send students of higher education institution for scientific research work on the issues of studying, passing pre-diploma and industrial practice and summarizing and analyzing the practice of judicial and investigative activities;

1.5. Participation in scientific-practical conferences and seminars on the problematic issues of criminal and criminal procedure.

2. DIA of Karaganda region:

2.1. Issuance of permits to employees of the Karaganda region DIA on participation in the educational process of the university;

2.2 Exchange of scientific, informational literature;

2.3 Assisting in the organization and conduct of training, graduation and industrial practice of HEI students and carrying out research work on the analysis and generalization of investigative practice;

2.3 Supervision and review of diploma projects, discussion of master theses;

2.4 Contributing to the updating of elective courses catalog, working curricula of the specialty;

2.4 Facilitation of teachers' professional development;

2.5. Assistance in organizing and conducting nominal classes.

The parties will hold joint working meetings and consultations to coordinate practical activities and develop specific measures.

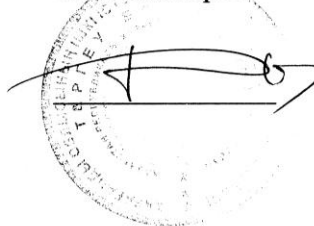
