- 1.5. Participation in scientifically-practical conferences and seminars organized by the Department of Revenues of the Karaganda region.
- 2. Department of Incomes of Karaganda region:
- 2.1. Permission for employees of the Department of Revenue of the Karaganda region to participate in the educational process of the university;
- 2.2 Exchange of scientific, informational literature;
- 2.3 Assisting in the organization and conduct of training, graduation and industrial practice of HEI students and carrying out research work on the analysis and generalization of investigative practice;
- 2.3 Supervision and review of diploma projects, discussion of master theses;
- 2.4 Contributing to the updating of elective courses catalog, working curricula of the specialty;
- 2.4 Facilitation of teachers' professional development;
- 2.5. Assistance in organizing and conducting nominal classes.

The Parties will hold joint working meetings and consultations to coordinate practical activities and develop specific measures.
