AGREEMENT ON THE ESTABLISHMENT OF THE EDUCATIONAL-RESEARCH-AND-PRODUCTION COMPLEX "IVS and Technologies" No. <u>1</u>

The Karaganda Economic University of Kazpotrebsoyuz, hereinafter referred to as the "University", represented by Rector AimagambetovErkara Balkaraevich, acting on the basis of the Charter, on the one hand, and «Artson Build Invest» LLP, hereinafter referred to as the "Enterprise", represented by Montaev Nurzhan, Director, acting based on the charter, on the other hand, hereinafter referred to as the "Parties", have concluded this agreement as follows:

1 SUBJECT OF THE AGREEMENT

The subject of the agreement is the cooperation of the Department of temporary detention facilities and the Enterprise in the field of education, science, production and the implementation of joint educational programs aimed at improving the training of specialists, advanced training of employees of the Enterprise, the introduction of new technologies, scientific developments, projects in the framework of educational-scientific-production complex "IVS & technologies".

2 GENERAL

2.1 Mutually beneficial cooperation of the Parties provides for:

- training and retraining of personnel with higher and secondary professional education for the Company in accordance with modern requirements for specialists;
- attracting specialists of the Company to participate in the educational process in the areas of training and specialties that are demanded by the Company;
- Exchange of experience in the development of advanced teaching methods and technologies;
- carrying out joint research work.
- 2.2 This Agreement defines the basic conditions for interaction between the University and the Enterprise. In the future, the Parties are entitled to expand the scope of this cooperation on the basis of additional treaties and agreements.

3 OBLIGATIONS OF THE PARTIES

3.1 University and Enterprise by joint actions:

- 3.1.1. Attract graduates of schools, lyceums, gymnasiums and colleges, as well as employees of the Enterprise to study at the University (as part of a joint career guidance work).
- 3.1.2 If there is a need, they provide the target trajectory of training students to work in the structural units of the Enterprise in the planned quantity and in the specialties and areas of training that are in demand in production.
- 3.1.3 Provide students with vocational guidance for admission to the structural divisions of the Enterprise upon graduation from the University.
- 3.1.4 Create conditions for improving the quality of students' training in areas of training and specialties corresponding to the profile of the enterprise.
- 3.1.5 Carry out joint research work in areas relevant to both Parties.
- 3.1.6 Spend joint conferences, exhibitions, presentations, olympiads.
- 3.1.7 For the constructive implementation of contractual relations, monitoring the implementation of the terms of this Agreement, the University and the Enterprise together may:
- create a council for coordinating and monitoring the implementation of the terms of this Agreement;
- conclude separate agreements within the framework of various joint projects of the Parties.

3.2 Obligations of the University

In order to implement this Agreement, the University:

- 3.2.1 Carries out the educational process in accordance with the requirements established by the State educational standards of the Republic of Kazakhstan, the legislation of the Republic of Kazakhstan and the Charter of the University.
- 3.2.2 Forms students' professional qualities in their chosen specialty, the ability to creative work, develops independence and initiative.
- 3.2.3 Timely informs the Company about the opening of new (closing of the existing) areas of training (profiles) and specialties at the University.
- 3.2.4 Attracts specialists of the Company to give lectures, conduct seminars, participate in examination commissions, conduct production, pre-diploma practices and manage (or jointly supervise) course and diploma projects of university students.
- 3.2.5 Organizes retraining and advanced training of managers and specialists of the Company, including using distance learning technology, in accordance with the submitted applications and on the basis of concluded agreements.
- 3.2.6 Provides an organized direction for internship in the structural units of the Enterprise of students studying at the University in the specialties and areas of training demanded by the Enterprise, in the amount and terms agreed by the Parties.

- 3.2.7 Carries out the selection of personnel for the Company in accordance with the stated vacancies and sends graduates who have graduated from the University for employment to the structural divisions of the Company.
- 3.2.8 Provides the employees of the Enterprise with the opportunity to speak to student audiences in order to orient them towards employment in the structural divisions of the Enterprise.
- 3.2.9 Provides assistance to the Company in conducting various contests, programs and grants announced by the Company by informing students and teachers and engaging them in participation.
- 3.2.10 Carries out the preparation of scientific articles, monographs, textbooks and teaching aids, workshops in conjunction with the employees of the Enterprise for their publication.

3.3 Obligations of the Enterprise

In order to implement this Agreement, the Enterprise:

- 3.3.1 Provides equipment, tools and other means of technical training for conducting training sessions and scientific and practical research;
- 3.3.2 Provides safe working conditions for students and teachers;
- 3.3.3 Provides advisory and methodological assistance on the use of software and hardware;
- 3.3.4. Prepares proposals on topics of term papers and final qualification works, as well as joint research and development in areas relevant to the Company, attracts leading employees of the Company to participate in them;
- 3.3.5 Participates in the optimization of curricula for the preparation of bachelors and masters in accordance with the conditions and development plans of the Enterprise;
- 3.3.6. Directs the leading specialists of the Company to conduct the educational process and participate in research on joint plans and programs;
- 3.3.7 Supervises production, pre-diploma practices and course and diploma projects of university students.

4 FINAL PROVISIONS

- 4.1 This agreement is valid for 5 years from the date it signed by the Parties.
- 4.2 The parties are obliged to notify about the change of their details no later than 10 days from the date of change.
- 4.3 All changes and additions to this Agreement must be made on paper and signed by the Parties.
- 4.4. The grounds and procedure for terminating this Agreement shall be determined by applicable law and by agreement of the Parties.
- 4.5 This agreement is made in two copies, one for each of the Parties.
