- 2.2 Place of study:
- 2.2.1. Creates and agrees insurance schedule within the curriculum with an insurance company.
- 2.2.2. Students are sent to the insurance company for a paid internship.

### 2.3. Parties:

2.3.1. To make proposals on all areas of cooperation as envisaged in this Memorandum.

# 3. Force majeure circumstances.

3.1. In the event of force majeure circumstances, the Parties are exempt from all liability for full or partial liability under this Memorandum, including, but not limited to, natural disasters, and consequently, the Parties can not fulfill their obligations, political tensions, disorder or military operations. or their consequences which may affect the performance of the terms of this Memorandum; the issuance of acts by government authorities or administrations that would not enable the Parties to perform contractual obligations; For any other reason not dependent on the control of the Parties.
