

**AGREEMENT ON THE ESTABLISHMENT OF EDUCATIONAL-
SCIENTIFIC- PRODUCTION COMPLEX "BANKER"
OF KARAGANDA ECONOMIC UNIVERSITY OF KAZPOTREBOYUZ
ON THE BASIS OF THE "BANKING" DEPARTMENT**

GENERAL PROVISIONS

1. 1. The educational-scientific-production complex is being created as one of the organizational forms of integration of education, science and production, the university's interaction with government bodies, industrial enterprises, service enterprises, the business community, aimed at improving the quality of training of specialists and their competitiveness in labor market.

1.2. Educational-scientific-production complex "Banker" is an association, which on a voluntary basis includes "Banking" Department of the University and Banks of the second level:

- Branch of JSC Jysan Bank in Karaganda, Branch of JSC BankCenterCredit in Karaganda, Branch of JSC Nurbank in Karaganda, Branch of JSC ATF Bank in Karaganda, Branch of JSC HalikBank in Karaganda, Branch of JSC Aifa Bank in Karaganda, Branch of JSC Kaspi bank in Karaganda, JSC SB Sberbank of Karaganda;

**1. PURPOSE AND MAIN TASKS OF THE EDUCATIONAL-
SCIENTIFIC-PRODUCTION COMPLEX "BANKER"**

The purpose of ESPC "Banker" activity is to increase the professional competencies of graduates by expanding the practical components of training by strengthening the ties of KEUK with the financial and banking environment, the business community, manufacturing enterprises and realizing the opportunities of students, young scientists in science, technology and new technologies.

To achieve this goal, the educational-scientific-production complex solves the following main tasks:

2.2.1. improving the organization of the educational process, by consolidating the interests of the university, science and the business environment and developing a unified approach in the formation of an adapted model of the graduate of KEUK, meeting modern needs and requirements of the society, owning new knowledge and competencies, new technologies, having competitive advantages, able to work in conditions Kazakhstan's integration into the global economic community;

2.2.2. development of an effective academic policy, providing for the transition from a standardization model of education to a model of independence and flexibility in academic matters, a transformation from a "university of teaching and learning" to an entrepreneurial and knowledge-based orientation;

2.2.3. harmonization of practice-oriented modular educational programs of the "Finance" specialty of Universities - partners aimed at obtaining entrepreneurial skills from graduates of KEUK through identifying achievements and features in the formation of entrepreneurial creativity in the educational space and identifying promising aspects of strengthening issues of academic mobility;

2.2.4. coordination of joint activities of its second-tier banks, business structures and enterprises of various ownership forms for the training, retraining and advanced training of specialists;

2.2.5. improving the effectiveness of educational and research work and the introduction of their results in production;

2.2.6. develops research work in the direction of the department with the involvement of students, undergraduates, doctoral students and teachers of KEUK;

2.2.7. organizes and conducts practices in order to strengthen the professional competencies of students, undergraduates, doctoral students of the specialty "Finance", promotes the employment of graduates;

2.3. In the interests of optimizing the activities of the ESPC, the Academic Council of KEUK can specify the tasks to be solved by the Educational-scientific-production complex.

1. FUNCTIONS OF THE EDUCATIONAL-SCIENTIFIC- PRODUCTION COMPLEX "BANKER"

1.1. In accordance with the assigned tasks, Educational-scientific-production complex "Banker" performs the following main functions:

1.1.1. attracting leading practitioners to organize the educational process from second-tier banks, business structures and enterprises of various forms of ownership;

1.1.2. organizes and conducts master classes, trainings and group consultations with students, undergraduates, doctoral students;

1.1.3. conducts individual consultations with students, undergraduates, doctoral students;

1.1.4. actualizes modular educational programs of the specialty "Finance", develops new curricula and teaching materials;

1.1.5. participates in the work of the State Certification Commissions, the open defense of group graduation projects of graduates, commissioned by second-tier banks, business structures and enterprises of various forms of ownership;

1.1.6. conducts activities for the professional orientation of students and potential students;

1.1.7. organizes internships by students in the branches of the department on the basis of second-tier banks and specialized organizations;

1.1.8. attracts students, undergraduates and teachers to implement research and applied analytical projects through the implementation of custom graduate and master projects, conducting empirical studies and compiling questionnaires to identify the needs of small and medium-sized businesses in credit resources, etc. ;

1.1.9. organizes scientific seminars, forums, round tables, conferences, international competitions for the best qualification work and the Department Olympiad "Leader-financier of the 21st century";

3.2. The main functions of the department included in ESPC:

- plans the educational process in the branches of the department and divisions of second-tier banks, business structures, enterprises of various forms of ownership;

- organizes the implementation of coursework, diploma and master's projects (works), educational research work of students on topics related to the solution of research and production tasks facing second-tier banks, organizations and enterprises of various forms of ownership;

- sends teachers, university employees to read to second-tier banks, business structures and enterprises of various forms of ownership of problem lectures and conduct classes to improve their skills and train their specialists;

- carries out research work on the subject of second-tier banks, organizations and enterprises of various forms of ownership on a contractual basis and under agreements on creative cooperation;

- invites experienced specialists from second-tier banks, business structures, enterprises of various forms of ownership to participate in the educational process on the conditions of part-time and hourly pay, as well as in the work of scientific seminars, platinum lectures, field lectures and practical exercises in the branches of the department and bases of enterprises; peer review of diploma, master's projects (works), modular educational programs, publications;

- invites top managers of the financial and banking sector, scientists of partner universities to conduct research projects, write joint collective research papers, monographs, manuals, textbooks, etc. ;

- participates in competitions of the best graduate qualification diploma, master's projects (works), international competitions, republican subject Olympiads, competitions of research projects (works), etc.

- carries out external and internal academic mobility, internships, advanced training of faculty, doctoral students, undergraduates, students at partner universities.

In the interests of solving the problems of the Educational-Scientific-Production Complex, the Academic Council of KEUK may specify its functions.

3.3. Expected results from the joint activity of participants in the process of ESCP "Banker" process:

- updated educational programs and catalogs of elective disciplines of the specialty "Finance" with the recommendations of top managers, experienced practitioners of the financial and banking environment and the business community;
- reviews of updated modular educational programs and catalogs of elective disciplines, textbooks and teaching aids,
- acts of implementation of completed diploma, master's, doctoral works, projects carried out by students, undergraduates and doctoral students by order of second-tier banks, business structures and enterprises of various forms of ownership;
- publications of joint collective research works, projects, monographs, textbooks, teaching aids, scientific articles;
- recording platinum lectures, visiting lectures and practical classes in the branches of the department and second-tier banks, master classes, trainings conducted by top managers of the financial and banking sector and experienced practitioners of the business community;
- reports and certificates of external and internal academic mobility of faculty and students, undergraduates (conducting online courses);
- reports and certificates of advanced training and internships at teaching staff and students, undergraduates in the branches of the department, second-tier banks, enterprises of various forms of ownership, business structures, etc.
- prizes in international, republican and regional competitions of qualification diploma projects, subject Olympiads, research projects;
- reports on the topics of the work programs of the teaching staff of the department for students of the business environment;
- ensure the effective functioning of the scientific offices of Dostyk coworking center.

4. PROCEDURE FOR THE ESTABLISHMENT OF EDUCATIONAL-SCIENTIFIC- PRODUCTION COMPLEX

4.1. ESCP "Banker" is created by the decision of the Academic Council of Karaganda Economic University of Kazpotrebsoyuz, on the basis of an agreement signed with the enterprise (organization).

5. FINAL PROVISIONS

5.1. The activities of ESCP "Banker" are annually reviewed and evaluated at a joint meeting of the department with the enterprise (organization) that are part of the ESCP.


5.2. ESCP "Banker" in its activities is guided by the current legislation, as well as this Regulation, taking into account the specific features of the work.


5.3. Funding for the work provided for by the joint plans of the university and the enterprise is carried out by the participants of ESCP at their own expense.
