## ARTICLE DESIGN REQUIREMENTS

Articles should be submitted to the editorial board in electronic form in RTF format.  
File name: "Name, short title of the article".

Articles will be accepted in Kazakh, Russian and English and must meet the following requirements:

In the upper left-hand corner, the MRSTI and the UDC are obligatory;

The author's full name, academic title and degree, position and place of work/study should be written in lower-case letters on the top line of the article. If the article has more than one author, the full name, academic title and degree, position and place of work/study of each author should be written in a comma separated line;

The title of the article should be typed in bold capital letters (12 point font size), centre-aligned and without a full stop at the end of the title;

followed by an abstract (typed in italics, 800 to 1000 characters with spaces) and keywords (at least three) in Russian/Kazakh and English without indentation;

The acceptable length of an article is 10,000 to 40,000 characters (with spaces) - approximately 5 to 15 typewritten pages;

page parameters: left margin: 2 cm; right margin: 2 cm; top margin: 2 cm; bottom margin: 2 cm; font Kz Times New Roman, Times New Roman;

The font size is 12, spacing is 1, alignment to the page width, indent from the fourth character of the line (0.9 cm);

references to sources in the text (in the sequence of appearance of the author's references to the sources used) should be in square brackets, indicating the page in accordance with GOST7.1-2003 "Bibliographic record. Bibliographic Description. General Requirements and Rules for Compilation;

When typing, you should not hard-copy words with a hyphen;

The abbreviations and acronyms used in the text should be disclosed the first time they appear in the text;

General references to the literature and sources used are given at the end of the article in Arabic numerals, without spaces, under the heading "List of references";

Tables, charts, diagrams, formulas and other graphic materials in the text should be numbered separately for each graphic material in accordance with GOST 7.1-2003 "Bibliographic Record. Bibliographic Description. General Requirements and Rules for Compilation".

The text submitted must be carefully edited to the specified requirements. Manuscripts and electronic media will not be returned, reviewed or restored.

The author(s) are responsible for the content of the articles.

The Organising Committee of the International Practical Conference reserves the right to publish or reject an article.
