Position in curriculum

The course "Theory and Practice of European Integration" is given as an additional elective course for International Relations and World Economy students (four year program). Credits for this course can be calculated in transcripts upon the will of the students.

This course is dedicated to studying specifics of theoretical and practical implementation of the European integration processes.

The purpose of teaching the course is to expand and deepen students' knowledge on consistent patterns of state and regional development and the role of regions in modern system of international relations.

Tasks of the course:

- to generate knowledge on different concepts and theories of integration;
- to form an understanding of regional integration processes;
- to generate knowledge on consistent patterns of functioning and development of European integration;
- to identify the interdependence of historical, political, economic, cultural and other factors in formation of the EU;
 - to develop skills of professional communication and research activity.

According to the program students will be able to study genesis and current state of the European Union, which is being a significant contribution to European Studies competencies of the future International Relations and World Economy experts.

Learning outcomes (competences):

- A. To know the patterns of development of regional integration theories and European integration ideas.
- C. To understand the role of the EU in the system of international relations, based on the historical processes and peculiarities of the political, economic and socio-cultural development of the entity.
- C. To be able to draw up a comprehensive description of integration stages of the EU, taking into account geographical, historical, political, social, economic, demographic, ethnic, cultural, religious and other characteristics.

- D. To be able to navigate the current trends in world development, as well as in European microregion.
- E. To apply comprehensive analysis when studying the relevant issues of European integration at regional and global levels.
- F. To be able to search, critically analyze, summarize and systematize scientific information, to set research goals and choose the best methods to achieve them, based on the principles of academic honesty, empathy and intercultural thinking.

Methodology of the course is defined by its peculiarities and purpose. The following methods should be applied: common scientific methods (observation, comparison, description), interdisciplinary approach, problem method, comparative method, project-methods, system analysis method, methods of content and event analysis, etc.

Course content

This course lays the theoretical foundation for a broad interdisciplinary and problem-oriented approach to European integration. The aim is to increase the theoretical understanding of legal, political, economic and social aspects of the European integration process by bringing forward different disciplinary insights and understandings of current European phenomena. The students will learn about the institutions, processes, practices and problems of European integration as well as gain an overview of, and an ability to critically reflect on and discuss, orally and in written form, current theory and research on processes of European integration.

The course is based on thematic lectures and seminars. Seminars are conducted in the form of discussions on relevant topics within the course content. Students can freely choose and propose topics for reports, presentations and discussions.
