Nurgalieva Rosa Nurgozhaevna graduated from the Karaganda Cooperative Institute of the Centrosoyuz in 1973 with a degree in Accounting, after which she was sent to full-time study at the pedagogical faculty of the Moscow Cooperative Institute of the Centrosoyuz (MKITS), now RUK. In 1974, after graduating from the pedagogical faculty of the ICIC, she qualified as a teacher of disciplines in the specialty "Accounting". From January 1985 to June 1986, she studied at the full-time graduate school of the ICIC, and in May 1987. She defended her PhD thesis in Moscow at the ZIST (Correspondence Institute of Soviet Trade). Since September 1974, he has been working at the Accounting Department of KKIC, KIPK, KEU, now KarUK, starting as an assistant, senior lecturer, now associate professor. Candidate of Economic Sciences since May 1987, Associate Professor of the Higher Attestation Commission of the USSR since January 1992.

In recent years, Associate Professor Nurgalieva R.N. has been teaching undergraduate courses at the university: "Financial Accounting -2" in Russian and state languages. In the Master's degree, he reads: "Financial Accounting (advanced)", Theory and methodology of accounting" in two languages. All the disciplines taught by her are fully methodically competently developed and designed according to the requirements of the university. UMK disciplines "Tax accounting", "Financial accounting 1", developed earlier by associate professor Nurgalieva R.N. are still used by other teachers of the department. Lectures, practical classes and SRMP are conducted at a high scientific and methodological level in Russian and Kazakh; she is fluent in PCs, social networks and distance learning tools. Enjoys a well-deserved reputation among colleagues, students and undergraduates. Many graduates of the Department of Accounting and Auditing of previous years are in constant contact with her. He is one of the veterans of KarUK. In 2022, she received a badge and a diploma "The best teacher of the CIS"

Associate Professor Nurgalieva R.N. is the first author and creator of the academic discipline "Tax accounting" in Kazakhstan (from 1998 to 2010 - her textbooks "Tax Accounting" were published three times). Has an author's certificate for the electronic textbook "Tax accounting" since 2017. In total, it was received: four copyright certificates - 3 from the Ministry of Justice of the Republic of Kazakhstan (2017-2022) and 1 from Ukraine in 2019. Under her authorship, 2 scientific monographs were written and published in Germany, Lambert publishing house: "Recognition, evaluation and accounting of financial instruments" - 2015 (6.0 pp.) and "Theory and practice of accounting and tax policy formation" - 2016 (5.5 pp.). In 2020 with her participation, co-authored a collective monograph "Formation of an information management system. Accounting, control, analysis. - Financial University under the Government of the Russian Federation. Moscow. Russia. RU-SCIENCE.COM/ 2020.

The successful work and contribution of Associate Professor Nurgalieva R.N. in the development of university science and in the scientific and methodological work of her native university, over the years of the formation of independent Kazakhstan, can be recognized as quite fruitful.

For the entire period of scientific and pedagogical activity, Nurgalieva R.N. has many publications of a scientific and scientific - methodological nature with a volume of more than 300 pp. Textbooks have been repeatedly developed and published: "Tax accounting", "Intermediate financial accounting in 2 parts", "Financial accounting (advanced)" in two languages and "Financial accounting — 2" - in Russian. In 2012, she wrote and published a textbook with the stamp of the Ministry of Education and Science of the Republic of Kazakhstan "Financial Accounting-2, which is widely used in many universities in Kazakhstan. Associate Professor Nurgalieva R.N. he publishes a lot of scientific articles in collections of international conferences in the near abroad, scientific journals of Kazakhstan and Ukraine. 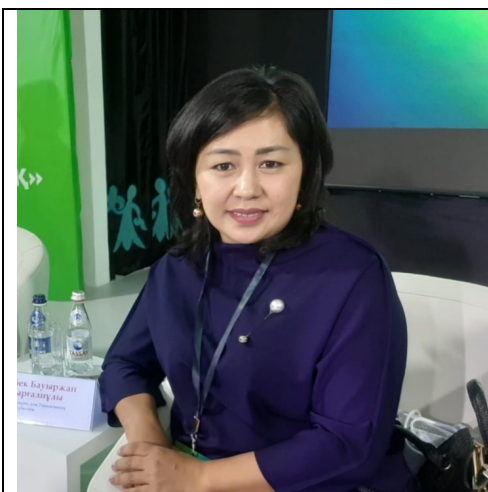


Mussipova Leilya Kamarovna
